Professor Chris Bellamy, Professor Emeritus of Maritime Security, University of Greenwich, Editor-in-Chief International Journal of Maritime Crime and Security, UK

Chris Bellamy is Professor Emeritus of Maritime Security at the University of Greenwich, where he was from 2010 to 2014 Director of the Greenwich Maritime Institute. He is also a visiting Professor at the University of Hull, and in 2018 completed a Visiting Research Fellowship on the Changing Character of War (CCW) Programme at the University of Oxford, on Hybrid Warfare in Russian Military Thought. He is the author of eight major books. His penultimate book, Absolute War: Soviet Russia in the Second World War (Pan/Macmillan, 2007, 2009, Knopf, 2008) has been translated into several languages – Spanish, Italian, Czech and Estonian, and for which he won the 2008 Westminster Medal for Military Literature. In 2019 he was appointed founding Editor-in-Chief of the new International Journal of Maritime Crime and Security (IJMCS), ISSN 2631-3855 (print), ISSN 2631-3863 (online). The first two issues (February and September 2020) are now available. In November – December 2019 he taught at the Bangabandhu Sheikh Mujibur Rahman Maritime University (BSMRMU) (Dhaka) from 30 November to 5 December.

Sarat Chandra Das has well over two-and-a-half decades of working career behind him, spanning television broadcasting, print and news media, publishing and teaching in Australia, Afghanistan, Nepal, Spain, Thailand, UAE, and the UK's higher and further education sector which accounts for nearly a decade of teaching in higher education space. Currently, Das works as dean (research) at C3S, Spain and co-owns Aspire Business School, Barcelona, Spain. Besides, he works with multiple American, Canadian, Australian and the UK universities setting up their approved centres, structuring their delivery on MOOC / VLE and arranging for research and academic collaboration with peer-group universities, institutes, and government agencies across the world. A large part of this delivery in recent years is arranged through his UK-based nodal company KiLax Ltd, Academy of Policy and Research, a London based think tank and seminar organisation which Das co-owns with others, and an official position Das keeps with Bucks New University (UK based public research university) as its regional director (partnership) located in UAE. Most of Das's education career has been in key positions involving teaching and overseeing the delivery of UK university programmes in institutions such as University of Wales, Anglia Ruskin University, University of Brighton at Hastings campus, and Cardiff Metropolitan University. He also worked with a Level 8 students research group. Prior to this, he was involved in managing editorial production of newspaper, news media, book publishing and television broadcasting. At the beginning of the pandemic, Sarat Das founded the public healthcare campaign 'Fight Corona' with local chapters dotting across the world.

Widely published in both scholarly press and popular media, Das in recent years largely shifted his focus to peer-reviewed academic journals and books following the assignment to cover the London Olympics for a syndication service (published with Yahoo!). His published portfolio in popular media includes Gemini (Panos Features), Dotlit (Australian literary magazine published by Queensland University of Technology), Times of India, Yahoo!, Statesman, Hindustan Times, Economic Times, Observer, Dataquest, Indrama, Blitz, Discover India, Swagat, Pioneer, Sify, Tribune, Northeast Sun, DNA, Deccan Chronicle, etc. Das's broad areas of research interest include disciplines such as philosophy, literature, social science, and cultural anthropology, and any of this subject area's crossover to management. This brings together selfsimilarity across scales - fractals - which drive thinking in enterprise development, risk management, markets, and marketing.

Title of the presentation: Organised Crime - Depletion of investigatory resources

#### **Brief synopsis**

Budget cuts reduced investigative resources and continuing uncertainty across the UK Police Service and other investigative authorities has presented many businesses and corporations with a big problem. Corporations are now asking "how do they get authorities to investigate the many financial irregularities happening within their businesses"? The UK police forces and authorised agencies are now ill equipped, under skilled to deal with time-consuming issues such as offences of financial crime, employee theft and 'scamming' in the same way as they did of old? Of the 43 police forces in the UK very few now have the capability to investigate fraudulent crime activity. The 'Action Fraud' website of 2009 (City of London Police) was set up as a 'one stop shop' for cases of fraud and/or financial crime, both for the private consumer and businesses. It allows for the self-reporting of cases, which are then referred to the relevant Police force for a line of enquiry. This could often take days or weeks if it is referred to at all. This is a clear example of a lack of resources to respond to cases of crime in a timely and professional manner that would, under normal circumstances, be expected by those reporting.

2021 has seen a new period of austerity and it has highlighted that private investigating is slowly becoming a mainstream occupation, the Government needs to see the evidence and realise that a solid network of private investigators throughout the country are openly operating that are available to be studied as a rich additional resource to bolster current law-enforcement. As a pilot insider researcher exercise the author attended a workshop at Oxford University covering "The Restructuring of the Global Economy", where business and academic leaders were present from 33 countries. The final consensus using a 'business to business' research model suggested that a research paper on this subject is long overdue and therefore regarded as a critical and necessary research subject. Those attendees at the conference also openly suggested the same exercise should be extended to gather the views of the public, as they would, as part of any investigation process, have exposure to the investigative authorities.

Historically the term "Good old policing skills" was in the past sufficient to deal with crime in its general form. Moving into the 21<sup>st</sup> century has seen an escalation of the sophisticated way criminals are perpetrating their crimes. To address this ever-evolving trend there must be a dynamic change in government policy and directives need to be put forward to change the way crime

investigation is undertaken. Over the past three decades extensive development in the areas of investigation laws and policy have arisen. There is now a need to evolve ever more to address the ever-growing virus that destroys society and cripples' global economies. Public perception of law enforcement is at an all-time low. Bridges must be rebuilt; confidence must be restored and failure to address either will result in a lawless society where the only direction is that of self-destruction.

So, as a critical focus this research aims to provide an original and significant contribution to academic knowledge that will have value as a source research paper about how private investigators can work in harmony, as a fully licenced and excepted agency that can work alongside with the police and other key statutory organisations at both strategic and operation level to address organised crime.

Title of the workshop: Demystifying Scientific Research

#### **Brief synopsis**

Researchers are truth seekers. They analyse, investigate, and interpret an event of the phenomenon. A true researcher does not make any speculations; instead, they bring the evidence after examining and testing. For them, the quest for proof is imperative and eternal. While we understand that some researchers will lose themselves in speculation, those with the method and integrity will always set to the task to seek out and test for evidence. It is vital for researchers to test, document, and verify all possible shreds of evidence and corroborate where possible. Rogue results, often caused by human error, tend to throw entire findings, hence the importance of repeat tests, multiple observations, random sampling, and benchmarking. Many of us have a distorted or ambiguous picture of the tasks of the researchers, and there are many misconceptions about the research. We, as researchers, should have a clear understanding of the research process. The research process can be the most interesting, exciting, and happier task for the researcher, not a tedious, dull, or complex process. The research should be well connected to our life, problems, and things we do every day. Furthermore, in an age of open access publishing, it has become seemingly more challenging to understand the critical ethical issues in research publication, and it seems many of us do not have a clear understanding of the ethical aspects of research especially, authorship, intellectual property, data fabrication, post-publication issues & corrections, peer review processes and many more

Despite the universal demand for scholarly writing and the publishing of learned papers, most institutions do not offer formal training or specialist workshops on writing influential articles and following the ethical aspects. This can frustrate young researchers and inhibit professional progress and place research in the public domain. Therefore, this talk's primary purpose is to discuss the research process in a simple format and the critical areas of ethical dimensions for the authors.

#### Title of the presentation

Slow Living, Slow Economy, and Slow Consumerism: Contentment is the Nirvana

#### **Brief synopsis**

The "slow movement" in consumerism relates to rational action in a particular manner, that is to say the action chosen by reasoning without haste. Prima facie sits at a sharp contrast to 'impulsive buying' causing cognitive dissonance for the consumer. Are numerous consumer goal-appropriated actions that are taken always turn out to be rational? Do the consumers always invest time thinking through his or her proposed action, the deliberation on how the action may hold out? Unfortunately, the current form of consumerism has led to unrestrained and obtuse consumption. Hence, Norwegian philosopher Guttorm Fløistad aptly remarked: "In order to master changes, we have to recover 'slowness, reflection and togetherness' which has a profound bearing on consumerism and choices." The research embarks on an inquiry to find out how the nomology of the mind works. The latter is the branch of science and philosophy concerned with the laws or principles governing the thought processes and operation of the mind, especially as defined by custom or culture, influence consumer choice that relates preferences to consumption expenditures. The discourse makes an inroad into an analytical framework of how consumers maximize the desirability of their consumption as measured by their preferences subject to limitations on their expenditures, by maximizing utility subject to a consumer budget constraint. The nomology based framework hints at a nomological network of relationships between constructs in decision making, the outcome of this needs to be put in the perspective of the current consumerism. It is interesting to speculate how the representation of the concepts (constructs) of interest in consumerism brings about the manifestations, and the interrelationships between these phenomena. Various necessary elements of a nomological network in consumerism need to be validated -- such as two constructs or theoretical propositions stating the underlying linkages between constructs, multiple correspondence rules allowing each construct to be measured empirically or even establishing the representing the various hypotheses centred around consumerism.
